

Groundbreaking For The Cove At 47th

The Cove at 47th development will be on the same site that was long supposed to be Village Square in downtown Cape at the corner of Cape Coral Parkway East and S.E. 8th Court, across from Cork Soakers restaurant.

Flaherty & Collins Properties purchased the 3.9-acre site from Downtown Village Square, LLC, in a deal brokered by Paulette duCharme Hansen with Miloff Aubuchon Realty Group's Commercial Division in Cape Coral.

The developer expects the first units to be ready in 16 months. The hope is for the entire project to be done by end of Summer 2024.

The Cove at 47th has been discussed for almost six years but has had several delays due to construction costs.

The developer for the project, Brian Prince, says he expects this project to bring in more than 170 jobs to the area.

"The number one question that big corporations are asking before they relocate to a new area is 'where are my people going to live?" said Prince. "If you don't have an attractive housing option in an urban walking environment, it makes it tough for you to compete in Fort Myers, Naples, Tampa, these other places."

This mixed-use project will bring in more than 300 luxury apartments, 19,000 square feet of ground-floor retail and office space. Other amenities include a 585-space parking garage with 125 spaces reserved for the public, rooftop bar and restaurant, and a saltwater swimming pool.

As it relates to the residential portion of this project, Prince says the goal is to allow people to afford to live here but also enjoy the amenities it comes with.

Amenities and features include an oversized, resort-style heated saltwater pool with lap lanes and beach entry, secured private offices and co-working space, fitness center featuring virtual

fitness and Yoga room, a rooftop sky lounge that will provide sunset views, pet spa, poolside grilling decks and firepits, secured garage parking with available private electric vehicle charging spaces and gig speed Wi-Fi in all common areas and offered in units. Apartments will feature modern designs and finishes, luxury wood



tile vinyl, quartz countertops, LED lighting, in unit washer and dryer, and private balconies. Three penthouse units include upgraded appliances, finishes, lighting packages and a built-in wine refrigerator.

"Average rent at this development will be just around \$2,000. We'll have a mixture of studios, one- and two-bedroom apartments and a couple of three's will be our penthouse on the top," Prince said. "Our studios will be in at the \$1,300 to \$1,400 range. So, it gives you an opportunity to get into the development and experience all of the great amenities that we have to offer. Heated resort-style, saltwater pools, we've got concierge, we've got fitness centers, a rooftop amenity deck for the residents that's no charge, watch the great sunsets that's to the west. So, we are very excited about offering price points for everybody within the development."

Quarterly Bulk Waste Drop-Off

Saturday, May 6

The city partners with Waste Pro and Lee County's Solid Waste Division to offer quarterly drop-off events to collect bulk items and household chemical waste (HCW). Waste will be collected from 7 to 11 a.m. on the following dates in the City Hall parking lot at 1015 Cultural Park Boulevard: Saturday, May 6 and Saturday, Aug. 5.



These quarterly events give residents another way to dispose of large items and a safe and responsible way to dispose of HCW. Residents should use the main entrance to City Hall on Cultural Park Boulevard to drop off items. Materials for drop-off will be collected from vehicle trunks and truck beds.

Proof of residency may be required to drop off items. Photo identification with a Cape Coral address and Cape Coral utility bills from an active account are acceptable items to prove your residency.

Bulk Waste Drop-Off Site For Residents

1200 Kismet Parkway, open Tuesday through Saturday, 8 a.m. to 4 p.m.

The bulk waste drop-off site is located on the west side of the North Cape Government Complex. The address for the complex is 1200 Kismet Parkway; however, the bulk drop-off site entrance is off N.W. 14th Avenue, at the western portion of the complex.

Commercial businesses are not permitted to use the facility because the program is an optional complementary service for residential use only. Proof of residency may be required to dispose of items. Household chemical waste and recycling will not be accepted at the drop-off location.

Items that will be accepted at the event include:

- Liquid paint and thinners
- Fluorescent tubesCar and boat batteries
- Car and boat batteri Gas propane tanks
- Yard Waste
- Pesticides/herbicides
- Polishes and strippers
- Electronics

- Mattresses
- No white goods will be accepted.

Remember When?...

The History Of Cape Coral **Street Names**

For newbies the streets can be more than a little confusing. That's why it helps to know the basics of how the city is laid out. After all, Cape Coral is much more than only its hundreds of miles of canals. To start with, the easiest way to look at the city is by understanding that Cape Coral is divided up into four quadrants. These are S.W., S.E., N.W. and N.E.. You'll notice that most street addresses include these prefixes; making it somewhat easier to at least understand which side of town you are on.

Santa Barbara Boulevard runs north and south, dividing the city east and west, while Hancock Bridge Parkway/Embers Parkway runs east and west, dividing the city by north and south. The intersection of the two is the center of the city.

From this point, you'll notice that roads are numbered, increasing as you drive away from the center. In other words, the largest road numbers are at the farthest point from the city's center. When looking for a home or business, the first part of the address signifies the closest intersecting road while the second is the number in that particular block. The exception is the Yacht Club, with named streets from A to Z, a few in the downtown area and some streets within subdivisions.

Generally, though, if you're looking for an Avenue, Place, Court or Boulevard, they all run south and north. Some of the main routes in this respect are Santa Barbara Boulevard, Chiquita Boulevard and Del Prado Boulevard. Many of these roadways are a safe bet for traveling through the region if you're not quite sure where you're going.

On the other hand, each Parkway, Terrace, Street or Lane runs east and west. Some of the main roadways going this direction include Veterans Memorial Parkway, Cape Coral Parkway and Kismet Parkway. Although a bit overwhelming in the beginning, once you do understand the basic layout, you'll find that Cape Coral is a fantastic city to live and explore.



The first eight houses in Cape Coral were built on Riverside and Flamingo Drives, at Redfish Point, near today's Cape Coral Yacht Club in 1958.



Did You Know?

Harney Point Road (Del Prado Boulevard) was the first road constructed in Cape Coral.

Cape Coral Parkway was the second. Coronado Parkway was the third.



This is a typical block in Cape Coral. Notice the private street in the lower right portion of the picture, with its wide turnaround. The sparkling, shimmering private waterways are part of a huge network of inland waterways, 80 to 200 feet wide and varying from to 6 to 20 feet deep. An average of 30 homes a month are being built at this waterfront wonderland. If pine and other trees have to be removed while building, they are replaced as rapidly as possible. In addition to having more canals than Venice, Italy, Cape Coral has a 230-mile shoreline.

Excerpt From Editor, News-Press, Wednesday, Nov. 13, 1963

There will be a hearing at the Lee County courthouse to determine if there are any objections to changing the name of Cape Coral streets to numbers.

This proposal is obviously promotional in nature, since running to a hundred will create the impression among out-of-state lot buyers that Cape Coral is already a huge city if people actually live, say on 1400 S.E. 62nd Court.

Tip From The Pro – Putting Drills

We always ask students what they feel is more important when putting, distance or direction?

Well, the absolute correct answer is both. But the best way to reduce your number of putting strokes is to control your distances when putting. If 1s and 2s are good scores, and 3s and 4s are bad scores when putting, then it is necessary to work on controlling your distances when putting during your round.

One practice drill we use is called a Ladder Drill. Place five tees about 10 feet apart in the shape of a ladder. While you practice, we want you to putt towards each tee with one ball. So you'll have the first ball at the 10-foot tee and the second ball at the 20-foot tee, and so on until you work up and down the ladder, making sure you can leave each ball within 1 to 2 feet of each tee. This drill helps with distance control.

Another drill we like is Around The World; place six golf balls in a circle around the hole at a distance of 4 feet. Hit each putt as its own. What we mean by that is do not just knock one in and move over to the next. Once you make the first putt we want you to walk away and read the second

putt and go through your routine and putt that one and so on around the circle until you have made all six without missing. This will make you better at short putts, and it will build a consistent routine that will make you better on all putts.

Try this, and if you need additional help, Coral Oaks' PGA staff has plenty of drills to help, so come join a golf school or take a lesson in one of our golf schools or clinics.
















Stamp Out Hunger Food Drive Set For May 13

Harry Chapin Food Bank and the United Way of Lee, Hendry, Glades and Okeechobee Counties will once again partner with the National Association of Letter Carriers as part of the Stamp Out Hunger food drive. The annual food drive will be held on Saturday, May 13.



Now in its 31st year, the

Stamp Out Hunger food drive is the largest single-day food drive in the nation and provides residents with a convenient way to donate food to those in need. Customers can leave donations of nonperishable food items next to their mailboxes on May 13. Mail carriers will collect donations along their regular postal delivery routes and distribute the items to food banks and other participating organizations.

Winter residents heading back up north before May 13 can still participate in the food drive by dropping off unopened, nonperishable food items in the lobby of the post office nearest their home. These items will be collected and distributed as part of the Stamp Out Hunger food drive.

Nonperishable food items include unopened, nonbreakable containers, such as peanut butter, pasta, tuna, rice, beans, canned meats, fruits, vegetables and soups.

Harry Chapin Food Bank and the United Way of Lee, Hendry, Glades and Okeechobee Counties partner with the National Association of Letter Carriers to ensure the food drive can be held each year. Hundreds of volunteers assist letter carriers by picking up food, unloading trucks and sorting items at postal drop-off sites.

Food collected in Lee County will be distributed by Harry Chapin Food Bank and other participating agencies, free of charge. The National Association of Letter Carriers food drive is pivotal in helping food banks, such as Harry Chapin Food Bank, and the agencies they serve continue to be supplied with food during the summer months, when school is out and there is a significant increase in food insecurity for children and families.

Volunteer Drivers Needed

We live in a generous community, so much that many of the letter carrier trucks overflow with food. The United Way Volunteer Center will be coordinating volunteers to assist with driving a carrier route and helping pick up food.

Volunteers will have a choice of driving routes primarily in the areas of Cape Coral, North Fort Myers and Fort Myers. As other areas are identified, they will be added to this list. Volunteer driver routes will start later in the morning to coincide with residents placing their food at mailboxes and the peak times when mail carriers are on their routes. This opportunity works best when volunteers team up in pairs, a driver and a navigator. Those under the age of 18 are welcome to help with written parental permission.

If volunteering in teams of two, both the driver and

navigator volunteer must register. If one of the volunteers is under the age of 18, the legal guardian will register and sign a waiver for themselves and the minor. Once registered for the opportunity, you will be contacted for your location preference. You may have to create a user profile first if you are new to volunteering with United Way or have not completed a user profile with us in the past. History Of Stamp Out Hunger Food Drive Day

National Stamp Out Hunger Food Drive Day is conducted by the National Association of Letter Carriers (N.A.L.C.). The drive was started in October 1991 as a trial program and took place across 10 cities in America. It was highly successful and has continued every year since. The initiative was formed by a union wanting to give back to those in need, whether it be by donating funds to a charity, collaborating during times of disaster, or protecting victims of calamities and crime.

The date for the drive was later moved to the second Saturday of May. The N.A.L.C. decided that the best time of year for the food drive would be in the late spring. This was because food banks and pantries ran out of food by May as donations decreased after Thanksgiving and Christmas.

It was the postmen who mostly saw the obstacles that communities faced. Thus, on this day, the postal carriers both deliver mail and collect food donations. As they deliver orders, bills, and postcards, people get to help out by filling their mailbags with nonperishable food donations.

One billion pounds of food have been dispatched over the last two decades. The mailmen deliverers representing the N.A.L.C. receive support from rural letter carriers, other messenger employees, and volunteers. In 2010, The Stamp Out Hunger Food Drive was awarded numerous badges, which include two Presidential Certificates of Achievement.



Options For Taxpayers With A Tax Bill They Can't Pay

Taxpayers who can't pay their tax bill by the April 18 deadline shouldn't panic. The IRS offers several options to help them meet their obligations.

It's important for taxpayers to file their tax return or request an extension of time to file at IRS.gov/extension by the April 18 deadline – even if they can't pay their full tax bill. Doing so will help them avoid a failure-to-file penalty.

This extension applies only to the filing deadline, not the payment deadline. Except for eligible victims of recent natural disasters who have until Oct. 16 to make various tax payments, taxpayers who can't pay the full amount of taxes they owe by April 18 should file and pay what they can. Making a payment, even a partial payment, will help limit penalty and interest charges.

For Taxpayers Who Cannot Pay In Full

Taxpayers struggling to meet their tax obligation may consider these payment options.

Online Payment Plans

Taxpayers who owe but cannot pay in full by April 18 don't have to wait for a tax bill to set up a payment plan. They can apply for a payment plan at IRS.gov/paymentplan. These plans can be either short- or long-term.

- Short-term payment plan The payment period is 180 days or less, and the total amount owed is less than \$100,000 in combined tax, penalties and interest.
- Long-term payment plan The payment period is longer than 180 days, paid in monthly payments, and the amount owed is less than \$50,000 in combined tax, penalties and interest.

Offers In Compromise

An **offer in compromise** lets taxpayers settle their tax debt for less than the full amount they owe. It may be an option if they can't pay their full tax liability or doing so creates a financial hardship. The IRS considers a taxpayer's unique set of facts and circumstances when deciding whether to accept an offer.

Taxpayers can see if they're eligible and prepare a

preliminary proposal with the Offer in Compromise Pre-Qualifier Tool.

The IRS Offers Penalty Relief To Eligible Taxpayers

Taxpayers may qualify for **penalty relief** if they tried to comply with tax laws but were unable due to circumstances beyond their control.

Here's What Taxpayers Should Know About Possible Penalties And Interest

Taxpayers who owe tax and don't file on time, may be charged a failure-to-file penalty. This penalty is usually 5 percent of the tax owed for each month or part of a month that the tax return is late, up to 25 percent. The failure-to-pay penalty applies if a taxpayer doesn't pay the taxes they report on their tax return by the due date.

Interest is based on the amount of tax owed and for each day it's not paid in full. The interest is compounded daily, so it is assessed on the previous day's balance plus the interest. Interest rates are determined every three months and can vary based on type of tax; for example, individual or business tax liabilities. More information is available on the interest page of IRS.gov.

An extension of time to file is not an extension of time to pay. An extension only gives taxpayers until Oct. 16 to file their 2022 tax return, but taxes owed are still due April 18.

QR Code 101 And How Does It Work?

You might be wondering, "How do QR codes work?" To answer you directly, QR codes store digital information accessible through a phone scan. These codes are accessed using a smartphone device. If you are only beginning to understand the basic works of a QR code, here is a guide for beginners to know more about QR codes and how QR codes are made.

Before we jump into the basic works of a QR code, we must first learn the basic concept of what is a QR code.

A "quick response code" also known as QR code is a twodimensional type of barcode. QR codes are scannable using smartphones devices, which are natively developed to scan/ detect QR codes.

These codes are generated using an online QR code generator that displays an online information to the scanner when scanned.

Today, QR codes are generally used in advertising, business, health care, and education.

However, business sectors, especially in the advertising and operations, most widely use QR codes.

Aside from these sectors, the restaurant industry also employs an interactive restaurant menu QR code software and QR code generators to generate a menu QR code for their business.

You can find QR codes in brochures, flyers, posters, billboards, items and products, business cards, and even online websites such as social media and shopping sites.

QR codes have since perpetuated into every industry and are used all over the world by consumers. It has started gaining a lot of popularity with consumers since scanning QR codes does not require an app. The camera app in both Android and iPhones is capable of scanning QR Codes natively.

Brief History Of QR Codes

The use of technology alleviates people's efforts in labor. QR codes had a specific problem to alleviate. In the early 1960s, the economy of Japan entered high economic growth.

During this period, supermarkets and convenience stores thrived and sold a wide range of commodities ranging from food to clothing. To keep up with the demand for checkout counters, the use of cash registers was implemented. Due to manual inputting in checkout and sales, cashiers at the checkout counters experienced numbness in their wrists and developed carpal tunnel syndrome.

As a solution to the problem, the point of sale (POS) system

was developed and incorporated the use of barcodes. In the long run, developers noticed the limitations barcodes had. The limit of 20 alphanumeric characters was not enough to hold a product's information and the position of how a barcode is scanned leads to scan failures.

Denso Wave stepped in and devised a new type of barcode that could hold more information and could be scanned in any scanner orientation.

How To Scan A QR Code - Apple

To scan a QR code on your iPhone, iPad, or iPod touch using the native camera app, follow these steps.

- 1. Launch the camera.
- 2. Point it at a QR code to scan.
- 3. Click on the notification banner at the top of the screen.
- 4. If the QR code contains any actionable data (contact number, email address, or an audio clip) tap on the banner to trigger the action or pull down the banner to reveal more information before you tap on it.

How To Scan A QR Code - Android

To scan a QR code on your Android phone using the native camera app, follow these steps.

- 1. Open the camera app on your Android device.
- 2. Move the QR code into the frame. If the code is easily scannable, you'll see the code's URL appear at the bottom of the frame. Tap it to open that URL.
- 3. View its contents displayed on the smartphone or click on the link to view its contents.

Garage Door Security

Drive down any South Florida street and you will likely find a number of open garage doors.

Reports of garage door openers being stolen from unlocked vehicles in the driveway have become more common, as well.

In addition to allowing access to any and all property left inside of the garage, these practices now turn your interior garage door into an exterior door. In most cases, interior garage doors are left unlocked to allow easy entrance into the residence.

That being said, an unlocked vehicle containing a garage door opener equates to leaving your front door open and accessible.

The internal garage door should meet exterior standards in regard to thickness, locking mechanism and framing.

These doors should be of solid-core construction and at least $1\frac{3}{4}$ inches in thickness. Choose a strong and secure deadbolt lock for this entranceway. Consider a "Grade 1" single-cylinder lock, a strong deadbolt strike plate and $2\frac{1}{2}$ -inch screws on all hinges.

The best preventative measures begin with a closed garage door and locked vehicles!
