

# Stamp Out Hunger Food Drive Set For May 11

Saturday, May 11 marks the 32nd anniversary of one of America's great days of giving – the National Association of Letter Carriers (NALC) Stamp Out Hunger® Food Drive.

Letter carriers travel through the communities daily, often coming face to face with a sad reality for too many, hunger.

Each year on the second Saturday in May, letter carriers across the county collect nonperishable food donations from customers. These donations go directly to local food pantries to provide food to people in Lee County who need help.

Over the course of its 30-year history, the drive has collected well over 1.9 billion pounds of food, thanks to a postal service universal delivery network that spans the entire nation, including Puerto Rico, Guam and the U.S. Virgin Islands.

feel hunger's impact on their overall health and ability to perform in school. Nearly 5.5 million seniors over age 60 are food insecure, with many who live on fixed incomes



# **Cape Coral Named Statewide Leader** In Urban Tree Canopy Growth

Typically, Urban Forestry studies are carried out at the city or county level, but this comprehensive analysis provides insights into the broader environmental and economic impact of trees across the state.

#### **Key Findings From The Southwest Region Include**

- The average urban tree canopy coverage in Southwest Florida is 32 percent.
- The Southwest region of Florida gained 4,000 acres of tree canopy, the highest among all regions studied.
- Cape Coral leads the state in adding tree cover, with an impressive 2,868 acres gained during the study period.
- Cape Coral showcases the largest potential planting area, covering 32,327 acres.



The increase in Cape Coral's tree cover is directly related to its economic development, which has allowed our city to grow a vibrant tree canopy that will benefit current and future generations. Establishing and maintaining a sustainable urban tree canopy is vital to the social and economic growth of our city.

Trees play a vital role in our city's green infrastructure and will become part of our cultural fabric as we continue to grow. The city will continue to seek new grant and reforestation initiatives to have our status as a leader in this field endure.

#### **Future Forestry – Planting** Trees For A Better Tomorrow

In the 1960s and '70s Cape Coral, Fla., was cleared of most of the natural tree canopy for the development of residential lots. The process of digging canals to raise the average elevation disrupted the area's natural foundation and soil.

Our mission is to rebuild the forest canopy and in the process clean the air, water and make a great home for other native plants and animals.

#### **Create The Forests Of Tomorrow**

The best time to plant a tree was 20 years ago, the secondbest time is today! Trees cool the earth and streets around them. This is south Florida; everyone could use some more shade and breaks from the heat!

#### **Improve Water Ouality**

Trees improve water quality by slowing rain as it falls to the Earth, and helping it soak into the soil. They also prevent soil from eroding into our waterways, reduce stormwater runoff, and lessen flood damage. They serve as natural filters to protect our streams, rivers and lakes.

#### Clean The Air

Trees absorb greenhouse gases (carbon, dioxide, nitrogen oxide) ammonia, sulfur dioxide and ozone and filter particulates out of the air by trapping them on their leaves and bark.

#### **Create A Thriving Habitat**

Trees provide shade that is necessary for keeping animals from the heat and protecting them from predators. Trees help support the entire food chain in a variety of ecosystems.

By springtime, many pantries are depleted, entering the summer low on supplies at a time when many school breakfast and lunch programs are not available to children in need.

Participating in this year's Letter Carrier Stamp Out Hunger Food Drive is simple. Just leave nonperishable food donations in a bag by your mailbox Saturday, May 11, and your letter carrier will do the rest.

Nonperishable food items include unopened, nonbreakable containers, such as peanut butter, pasta, tuna, rice, beans, canned meats, fruits, vegetables and soups.

With your help, letter carriers and the U.S. Postal Service have collected over 1.9 billion pounds of food in the United States over the 30 years as a national food drive. Please help in the fight to Stamp Out Hunger.

# Groundbreaking **At Festival Park**

The City of Cape Coral invites the public to a groundbreaking ceremony for Festival Park on Friday, May 31, at 10 a.m. No reservation is required to attend.

In 2018, Cape Coral voters approved a \$60 million expansion of the city's parks and recreation amenities. The approved 15-year general obligation bond will fund major parks and recreation improvements throughout the city.

This park's development intends to provide festival grounds for large events and an outdoor concert venue. Proposed park improvements include four multiuse sports fields with lighting and an amphitheater with a grass berm. Festival Park is expected to open in the fall of 2025.

"It's brunch all day long, and it's all fresh," said coowner Eric Gentry. "And that's what makes us unique in Cape Coral."


Co-owner couples Frank and Sandra Kelly, along with Eric and Shelley Gentry have all worked together to make BARunch something different and something special.



### Tax Talk

# **Tax Reform Provisions That May Affect Your Business**

Now that the tax season is over it is time to concentrate on your business more and how the Tax Reform Provisions may affect your business.

# **Income (Including Gains And Losses)**

#### **Inventory Sourcing**

Income from the sale of inventory where title passes outside the United States generally would be foreign source income. If a domestic corporation manufactures inventory in the United States and passes title and risk of loss outside the United States, prior law provided that 50 percent of the income would be United States source and 50 percent would be foreign source. The Tax Cuts and Jobs Act, or tax reform, modified this rule to provide that 100 percent of the income from the sale of property manufactured by the corporation in the United States is United States source, regardless of where the title passes.

If a domestic corporation manufactures inventory outside the United States, 100 percent of the income from its sale would be foreign source, regardless of where title passes and regardless of whether the inventory is sold to United States or foreign customers. If, instead, the domestic corporation purchases inventory that it sells, the sales income would be sourced based on where title and risk of loss pass to buyers.

#### **Limitations On Carried Interest**

The law extended the holding period with respect to certain carried interest (i.e. applicable partnership interests) to three years.

Carried interests are ownership interests in a partnership that share in the partnership's net profits. Carried interests often are issued to investment managers in connection with the investment manager's services. These interests often result in the holder receiving capital gains which are taxed at a lower rate, rather than ordinary income.

#### Like-Kind Exchange

The law, Section 1031 changed like-kind exchanges and now it applies only to exchanges of real property and not to exchanges of personal or intangible property. An exchange of real property held primarily for sale still does not qualify as a like-kind exchange.

#### **Deductions And Depreciation**

#### **Business Interest Expense**

Newly amended section 163(j) of the Internal Revenue Code imposes a limitation on deductions for business interest incurred by certain large businesses. For most large businesses, business interest expense is limited to any business interest income plus 30 percent of the business' adjusted taxable income.

#### **Qualified Business Income Deductions**

Owners of sole proprietorships, partnerships, corporations and some trusts and estates may be eligible for a new deduction – referred to as Qualified Business Income Deduction – allowing them to deduct up to 20 percent of their qualified business income, plus 20 percent of the aggregate amount of qualified real estate investment trust dividends and qualified publicly traded partnership income.

#### **Depreciation And Expensing**

Businesses can immediately expense more under the new law. A taxpayer may elect to expense the cost of any section 179 property and deduct it in the year the property is placed in service. The new law increased the maximum deduction from \$500,000 to \$1 million. It also increased the phase-out threshold from \$2 million to \$2.5 million.

Proposed regulations have been issued on the new 100-percent depreciation deduction that allows businesses

• Cape North (two shifts – 11 a.m. to 2 p.m. and 2 to 5 p.m.) Volunteer driver routes will start later in the morning to coincide with residents placing their food at mailboxes and the peak times when mail carriers are on their routes. The second shift will collect items from residents who put out their donations later.

### History Of The Letter Carrier Stamp Out Hunger® Food Drive

Letter carriers, who go into neighborhoods in every town six days a week, have always gotten involved when something needs to be done. Whether it is collecting funds for the Muscular Dystrophy Association (MDA); watching over the elderly through the Carrier Alert Program; delivering needed antibiotics (if called upon); assisting victims of natural disasters, or rescuing victims of fires, crime, and other mishaps, letter carriers are the eyes and ears in every neighborhood and often lifesavers in the community.

Over history, a number of branches collected food for those in need as part of their community service effort. Discussions were held by the NALC, USPS, and AFL-CIO to explore a more coordinated effort. A pilot drive was held in October 1991. It proved so successful, the parties worked to make it a nationwide effort. Food banks and pantries suggested that late spring would be the best time for the drive, since most of their food donations are received over the Thanksgiving and Christmas holiday periods, leaving the food shelves depleted by spring. Making matters even worse for many, school breakfast and lunch programs are not available during the summer, placing an even greater responsibility on local food pantries and food shelves.

A revamped drive was organized for the second Saturday in May 1993, with a goal of at least one NALC local branch participating in each of the 50 states. The results were astounding. Over 11 million pounds of food

were collected by over 220 union branches – a one-day record in the United States. From Alaska to Florida and Maine to Hawaii, letter carriers did double duty by delivering the mail and picking up donations. In 2022, we celebrated the return of the in-person food drive which was our 30th annual Letter Carriers' Stamp Out Hunger food drive. Our branches have collected a total of approximately 1.9 billion pounds of food over the history of the drive – an awesome achievement.

Each year, groups, businesses and organizations join the NALC at the local, regional, and national levels, to help grow a campaign of hunger awareness and community action in conducting this one-day, record making food drive. From the beginning, at the national level, we have had the steadfast support of the USPS, United Way and AFL-CIO. United Food and Commercial Workers union (UFCW) is the national premiere partner, adding the largest food union in the country to our efforts. Locally, the Letter Carrier Stamp Out Hunger food drive enjoys partnerships with many church and faith groups, Rotary and Lions Clubs, grocers and youth groups and those who work to provide help and hope to those in need.

We look forward to another awesome year, as we continue our fight to **Stamp Out Hunger!**

### Stamp Out Hunger Food Drive Day FAQS

#### What Is Special About Nonperishable Food?

Nonperishable foods, such as canned goods and dried fruit, have a long shelf life and don't require refrigeration to keep them from spoiling.

#### What Percentage Of Americans Use Food Banks?

One in seven people in our nation utilizes our network of food banks.

#### Who Refers You To A Food Bank?

Professionals such as social workers, healthcare practitioners, and doctors must refer people to a food bank for them to receive a voucher that can then be exchanged for food.

to write off most depreciable business assets in the year they are placed in service by the business.

#### **Employer Deduction For Certain Fringe Benefits**

The new law disallows employer deductions for (1) activities generally considered to be entertainment, amusement, or recreation; (2) membership dues for clubs organized for business, pleasure, recreation, or other social purposes; or (3) a facility used in connection with the above items, even if the activity is related to the active conduct of trade or business.

It also disallows deductions for expenses associated with transportation fringe benefits or expenses incurred providing transportation for commuting (except as necessary for employee safety).

Under the new law, there is now a prohibition on cash, gift cards and other non-tangible personal property as employee achievement awards. Special rules allow an employee to exclude certain achievement awards from their wages if the awards are tangible personal property.

#### **Business Meals**

Business meals have been reduced to 50 percent of the total cost of any business-related meals.

The five-acre project will be in northeast Cape Coral at 2601 Del Prado Blvd. N.

It will be groundbreaking in the next few months, with a plan to finish within a year, possibly by 2025.

#### Victory Park

Victory Park, a 138-acre life science campus in northeast Cape Coral, will include a main medical office complex, hundreds of housing units, a hotel, and a multiuse path.

It is between Diplomat Parkway East, N.E. 24th Avenue, Littleton Road, and Corbett Road, next to the VA Clinic Cape Coral.

Civitas of Cape Coral is a 4.65-acre, affordable, workforce multifamily community with 96 units at 123 Civitas Court, near Pine Island Road.

#### Shops Of Del Sol And Shops Of Del Mar

They will be at 1019-1027 S.W. Pine Island Road, between Chiquita Boulevard and Santa Barbara Boulevard in Cape Coral.

They will bring restaurants, retail, medical, and recognizable brands and shopping with a sleek and modern design.

#### **Cape Coral Grove**

Cape Coral Grove is a "town center" project bringing more than 1,234 multifamily apartment units, two public parks, a hotel and parking spaces.

The 131-acre parcel is next to Bubba's Roadhouse on Pine Island Road and will be 767,000 square feet.

#### Gilbane

A 35-acre parcel at Pine Island Road and Veterans Parkway will bring a three-phased project with a 120-unit hotel, freestanding restaurant and 10,000 square feet of retail.

Additionally, 600 apartments are planned in two phases.

#### Lake Shadroe

White Stone Developments, a Cape Coral-based real estate developer, is developing a 48-unit Airbnb vacation resort for the growing northwest part of Cape Coral.

The site is surrounded by residential areas and next to the city's Burnt Store Boat Ramp, a 4.5-acre boat launch facility that provides access to the North West Spreader canal.

Other amenities would include a waterfront restaurant, a gourmet café, a marina, a spa and a cigar bar.

Plans for a mini marina will include 12 boat slips that will be rented out and reserved for different water-based activities like fishing and kavaking.

#### Lee Health And Bimini Square

Bimini Square is a mixed-used development west of Four Freedoms Park that will include luxury apartments, a Deep Lagoon waterfront restaurant and shops on three sites south of Cape Coral Parkway and west of Sunset Court.

The project consists of 13 parcels with five-story buildings on nearly six acres and includes a 25-slip transient boat dock, a parking garage, 500 spaces and a commercial parking lot for the restaurant.

Medical office space compromises about 95 percent of the street floor frontage along Cape Coral Parkway.

#### The Cove

The 3.9-acre site will have 19,000 square feet of retail, commercial and office uses on the first floor, four restaurants, 327 luxury residential units and a 611-space parking garage, with two floors reserved for the public.



# **Bulk Waste Drop-Off**

#### Saturday, May 4

The city partners with Waste Pro and Lee County's Solid Waste Division to offer quarterly drop-off events to collect bulk items and household chemical waste (HCW). Waste will be collected from 7 to 11 a.m. in the City Hall parking lot at 1015 Cultural Park Blvd., Saturday, May 6.

In addition to the city's longstanding partnership with Lee County's Solid Waste Department to collect bulk items and HCW, we are now partnering with Habitat for Humanity to repurpose gently used bulk items.

Residents are encouraged to bring items that can be donated for reuse. No white goods, such as refrigerators or dishwashers, will be accepted.

These semiannual events give residents another way to dispose of large items and a safe and responsible way to dispose of HCW. Residents should use the main entrance to City Hall on Cultural Park Boulevard to drop off items. Materials for drop-off will be collected from vehicle trunks and truck beds.

Proof of residency may be required to drop off items. Photo identification with a Cape Coral address and Cape Coral utility bills from an active account are acceptable items to prove your residency.

- Drain cleaners and pool chemicals
- · Pesticides/herbicides
- Liquid paint and thinners

- Polishes and strippers
- Fluorescent tubes
- Electronics
- Car and boat batteries

- No white goods will be accepted.

#### **Year-Round Bulk Waste Drop-Off Site For Residents**

The city reminds residents of Cape Coral's bulk waste drop-off site, 1200 Kismet Parkway, open Tuesday through Saturday, 8 a.m. to 4 p.m. is available year-round. The site is a complimentary service in addition to the residential bulk item collection provided on collection days.

The bulk waste drop-off site is located on the west side of the North Cape Government Complex. The address for the complex is 1200 Kismet Parkway; however, the bulk drop-off site entrance is off N.W. 14th Avenue, at the western portion of the complex.

Commercial businesses are not permitted to use the facility because the program is an optional complementary service for residential use only. Proof of residency may be required to dispose of items. Household chemical waste and recycling will not be accepted at the drop-off location.

# **Cape Coral Historical Museum**

### Remember When... Fishing In The "Ole Days"

Many Cape Coral anglers would start their day with a stop at Tom Corbett's tackle shop at the Yacht Club pier. If they were fishing from the MUSEUM OF HISTORY



pier, Tom sold bait – mostly shrimp – to help fishermen land the big one. If they were headed out onto the water, he sold gas too. The shop was affectionately called the "Bait Shack."

One of the great early fish tales coming out of Cape Coral took place Saturday, May 11, 1968. John Clark had gone out fishing in the Caloosahatchee River when he hooked something enormous. Clark told the local newspaper, "We had no idea of what we had on, but we knew he was big. He would surface, making a snorting noise, much like the snorting of a horse."

Clark had hooked a 14-foot, 3-inch sawfish. Clark's boat was only 19 feet long, and soon the great fish was heading up the river, towing the boat behind it. Clark fought the fish for more than four hours before finally landing it. Back at his canal front home, a crane donated by a local construction firm lifted the fish off the lawn. Clark had been telling people that just a John Clark and prize fish week earlier he



had hooked a giant fish in the Caloosahatchee, but it got away with his wire leader. No one believed him. A week later, when Clark caught this beast, his wire leader was wrapped around its saw. The meat from the nearly 600-pound fish was donated to a local zoo, while Clark kept the 38-inch-long saw as a memento.

## **Consumer Alert**

### What's A Verification Code **And Why Would Someone** Ask Me For It?

When you log into your bank or credit card account, you might get a text message or email with a verification code. You then enter it at the login screen to confirm it's really you. That's a form of two-factor authentication that adds a layer of security to your account — and keeps would-be scammers and hackers out.

Your account password and a verification code work together, like the lock on your doorknob and a deadbolt lock. If you unlock the doorknob but not the deadbolt, you can't get in. Likewise, if you know the account password but not the verification code, you can't get in.

The same goes for scammers trying to get into your account. To break into your account, scammers need both keys. That's why they try to trick you into sharing your verification code.

Scammers pretend to be someone you can trust, and say they've discovered a problem with one of your accounts or that someone's using your identity. They may know some things about you and sound very convincing. They may even be very sympathetic to your problem: offering to help you set things right ... and then asking for your verification code to get into your account.

If you give them the code, they can log into your account and transfer all the money out of your savings or investment accounts.

Never give your verification code to someone else. It's only for you to log into your account. Anyone who asks you for your account verification code is a scammer.

If someone asks you for your verification code, don't engage. Hang up. Block their number. Stop texting them. Then report them to the FTC at ReportFraud.ftc.gov.

If you're worried there's a problem with your account, contact your bank, credit union, or investment advisor directly. Use a number you trust, like the one on your statement or in your app. Never use the number the caller gave you; it'll take you to the scammer.



# **Paving Potholes** For Smoother, Safer Roads

Potholes – those pesky craters on our roadways – are not just a nuisance; they pose danger to drivers and pedestrians. The City of Cape Coral has a dedicated team that works tirelessly to address these hazards, ensuring a safer journey for all.

The city has two dedicated pothole crews, each made up of three members with specialized pothole trucks. This team of six is armed with the tools and expertise to tackle these road imperfections head-on.

#### What Causes A Pothole?

Potholes form when water seeps beneath the asphalt layer, causing voids. As vehicles travel over the weakened roadway, the asphalt flexes and chips away. Potholes aren't unique to Cape Coral.

They can be found on roadways nationwide. But Cape Coral crews have proactive measures for repair in place. Crews prioritize high-volume roadways across the city before addressing minor side roads. They divide the city into quadrants, efficiently tackling the repair requests. However, if the damage is extensive - six or more potholes within a 30-foot area - they patch the area and alert the city's resurfacing staff so more comprehensive repairs can be made.

#### How Can You Help?

If you come across a pesky pothole, providing a specific address is vital.

Clear and accurate location information helps crews expedite repairs, minimizing the time wasted on unsuccessful searches.

Pothole repair is crucial to maintaining safe and functional roadways in Cape Coral. Thanks to the dedication and efficiency of the city's pothole crews, drivers and pedestrians can navigate the streets with greater peace of mind. By working with the community, Cape Coral continues to make strides in enhancing road safety.


